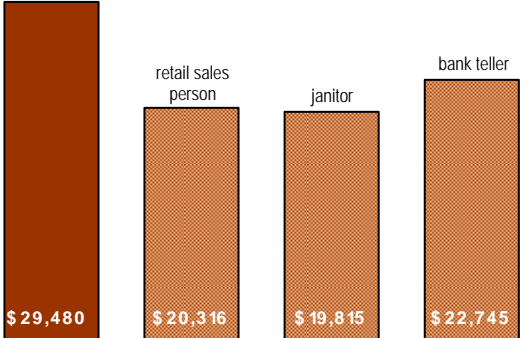


Annual Income Required to Afford a 1-BR Apartment in Clackamas County

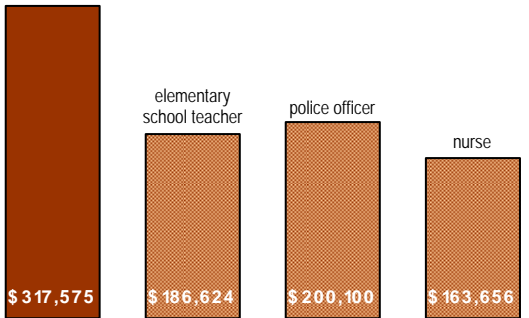


Annual Income Required to Afford a 2-BR Apartment in Clackamas County

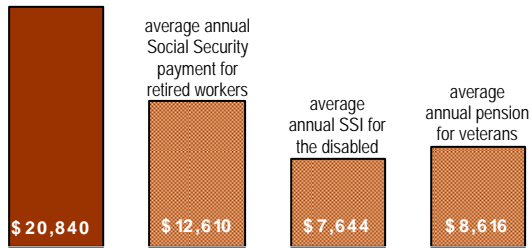

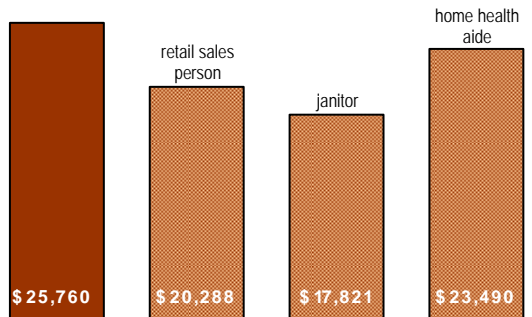


Annual Income Required to Afford a 1-BR Apartment in Clatsop County

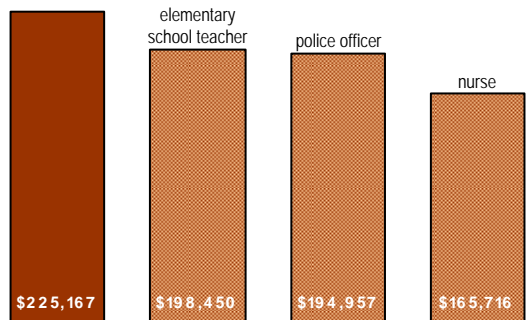


Annual Income Required to Afford a 2-BR Apartment in Clatsop County

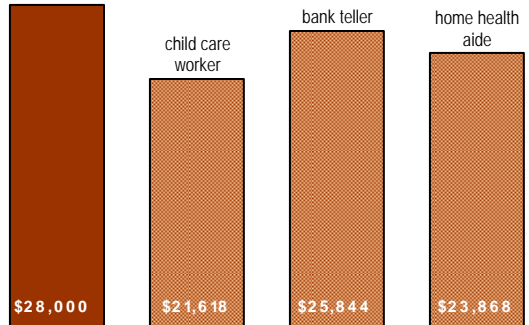


Annual Income Required to Afford a 1-BR Apartment in Deschutes County

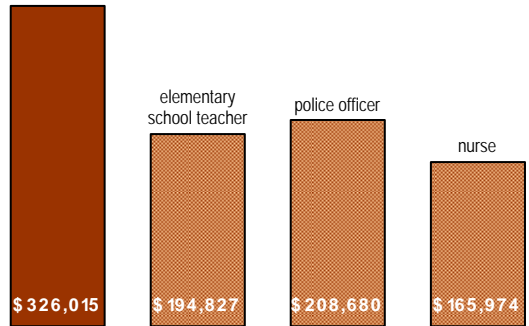


Annual Income Required to Afford a 2-BR Apartment in Deschutes County

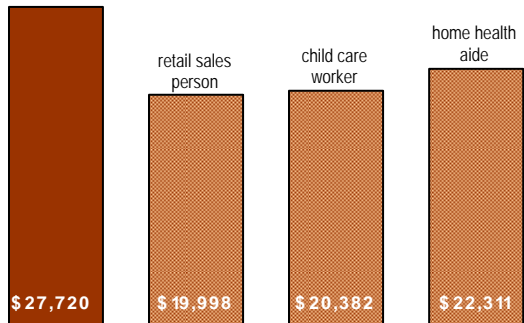


Annual Income Required to Afford a 1-BR Apartment in Lincoln County

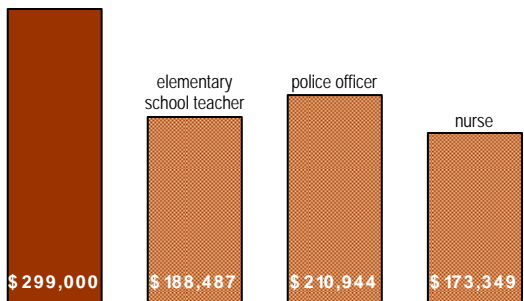


Annual Income Required to Afford a 2-BR Apartment in Lincoln County

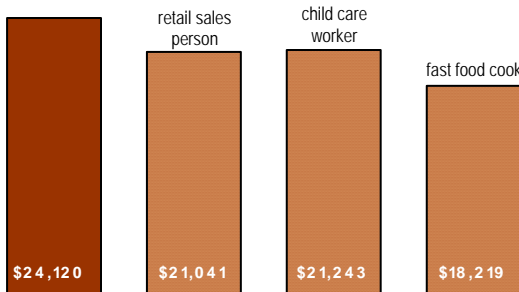


Annual Income Required to Afford a 1-BR Apartment in Sherman County

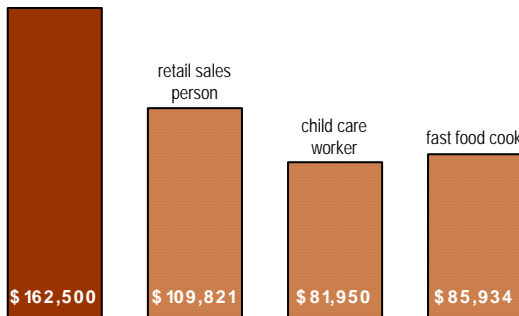


Annual Income Required to Afford a 2-BR Apartment in Sherman County

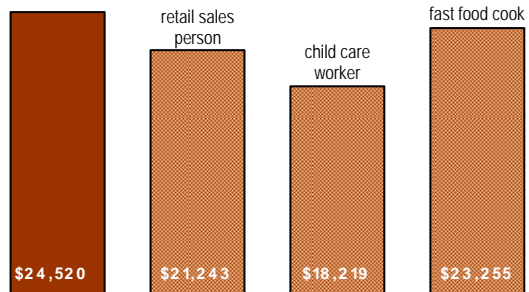


Annual Income Required to Afford a 1-BR Apartment in Wasco County

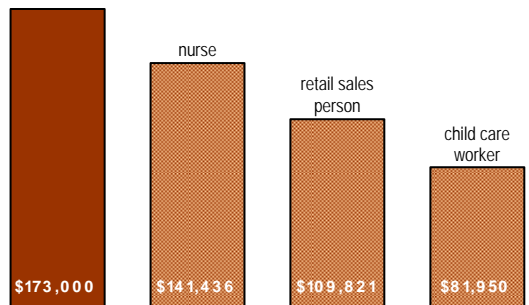


Annual Income Required to Afford a 2-BR Apartment in Wasco County
